

Terms and Conditions

Paragon Construction Group Ltd

1. Acceptance of Quote and Payment Terms:

1.1 By accepting a quote provided by Paragon Construction Group Ltd (hereafter referred to as "PCG"), the customer agrees to be bound by these Terms and Conditions.

1.2 The customer acknowledges that the acceptance of the quote constitutes acceptance of the outlined payment terms specified within this document.

2. Payment Terms:

2.1 Payment shall be made by the customer to PCG in accordance with the agreed-upon terms outlined in the quote.

2.2 Unless otherwise specified, full payment is due upon completion of the construction project. PCG reserves the right to invoice the customer for the final payment upon substantial completion of the work.

2.3 In certain cases, PCG may require partial payment at a mid-point in the project. The customer will be informed of such requirements in advance, and payment for the specified milestone must be made within the stipulated timeframe.

3. Late Payment:

3.1 Late payments may be subject to interest charges. Interest will accrue at a rate of 20% per month on the outstanding balance, calculated from the due date until the date of payment.

4. Dispute Resolution:

4.1 Any disputes regarding payments shall be communicated in writing to both parties within 14 days of the issue arising.

4.2 In the event of a dispute, both parties agree to engage in good faith negotiations to resolve the matter amicably.

5. Changes to Scope of Work:

5.1 Any changes to the scope of work that may impact the cost of the project will be communicated to the customer promptly.

5.2 PCG reserves the right to adjust the quote and payment terms accordingly for any approved changes to the project scope.

6. Termination:

6.1 Either party may terminate the contract if the other party is in material breach of its obligations and fails to remedy such breach within 14 days of written notice.

6.2 In the event of termination, the customer agrees to pay PCG for all work completed up to the termination date in accordance with the agreed-upon payment terms.
